In an effort to contain the spread of COVID-19, and in compliance with Sarasota County School's policy, all events at the Venice Performing Arts Center will be suspended, rescheduled, or postponed starting on Tuesday, March 17<sup>th</sup> 2020 until further notice.

The program, Dancing Dream- A Tribute to ABBA originally rescheduled to Saturday, November 14<sup>th</sup>, 2020, and Good Vibrations, a tribute to the Beach Boys are being further rescheduled to 2021, dates to be determined.

The Venice Symphony's concerts with Linda Eder scheduled for March 27<sup>th</sup> and 28<sup>th</sup> 2020 have been rescheduled to Saturday May 1<sup>st</sup>, and Sunday May 2<sup>nd</sup>, 2021. Please be patient with us as we work to determine the best course of action for all events scheduled after March 28<sup>th</sup>, 2020.
